

**THIS INDENTURE WITNESSETH AS FOLLOWS**



## I. OBJECTS:

The objects of the Trust are:

1. To construct, establish, run and maintain Medical Colleges, Engineering Colleges, Management Colleges, Nursing College, ITI, Polytechnic for providing medical, technical, professional, vocational for providing education and training like MBBS, MS, MD, DM, BAMS, BMS, BDS/MDS, B.Tech, M. Tech, MBA, BBA, BBA, MCA, Nursing in ayurved/allopath, Para-Medical, diploma, degree courses including their post graduate and diploma courses or any other course the benefit of general public.
2. To construct, establish and run Schools, Colleges, and Educational Institutions for running various primary, junior high school, high school, intermediate, degree courses including graduation and post graduation including B.A., B.SC., B.COM, B.ED., B.Sc.(AG), M.A., M.COM, M.SC., M.Sc.(AG), M.ED, M.P. ED., B.P. ED., B.SC. (NURSING), B.T.C., or other educational courses for the benefit of the students/public.
3. To construct run and operate hospital, nursing home, clinic, laboratory, diagnostic center, trauma center or any place to provide all types of medical facilities for treatment of all types of diseases including surgical facilities.
4. To provide grants, scholarships, fellowships and other forms of financial assistance to the needy and deserving students for pursuing education, vocational training, skill development etc.
5. To provide financial assistance to any educational institution for establishing and running the schools, colleges, educational institutions, granting scholarships, prizes, medals, awards for excellence in studies, sports and scientific research on of books and note books for poor and deserving students.
6. To provide financial assistance to the deserving persons for medical treatment, in any medical institution and to organize medical camps for diagnosing, advice and treatment of all types of diseases.
7. To provide financial assistance for performing annadhanam and feeding the poor directly and through other institutions.
8. To organize camps with or without the help of other institutions, companies, societies for family welfare, child care and development, family planning, prevention from drugs/alcohol abuses, AIDS and other social evils.
9. To establish, conduct, maintain old age homes, shelter homes, orphanage homes, homes for physically challenged men, women and children and persons with similar disabilities and also grant financial assistance to institutions performing similar activities.
10. To grant of donation to any Temple, Mosque, Church, Gurudwara, educational institutions and other religious/charitable institutions. However, the Trust shall not undertake any religious activities.

11. To establish, run and maintain day care homes, crèches and nurseries for children.
12. To provide for or contribute to education and scientific research and development.
13. To provide relief to the poor and advance any other object of general public utility.
14. To organize camps and provide food, medicines, medical and financial assistance in any area effected by flood, earthquake, drought or any natural calamities.
15. To sponsor any game, event, tournament, camp etc. organized for development of any game, skill, knowledge, personality of general public.
16. The Trust will not carry out any activities with the intention of earning profit and will perform with service motive only.
17. To develop, take on lease, maintain parks, recreation centers, entertainment center for general public without any restriction as to religious/caste.
18. No activities of the Trust will be carried out outside India.

## II. BENEFICIARIES OF THE TRUST:

The Trust is established for the benefit of citizens of India without discrimination of any caste, religion, creed or sex.

## III. PROPERTIES:

The Trust properties shall consist of

1. The amount Transferred by the **SETTLOR** as mentioned above, towards the Corpus fund of the Trust.
2. Any cash, kind, properties, movable and immovable that may be acquired by purchase or otherwise or all manner of rights, title or interest in or over any property movable or immovable.
3. All additions and accretions to the Trust properties and the income there from.
4. All donations, gifts, legacies or grants, in cash or kind accepted by the **Trustees** upon Trust.
5. All grants, helps, contributions received in cash, kind, properties or in any other form from any person, institution, department, authority, body, company, govt., MLA/MP Nidhi etc.
6. Any other receipts received by the trust from any legal source.

The properties of the Trust shall be utilized for the objects set forth herein above and subject to the provisions and conditions herein mentioned.

#### IV. NUMBER OF TRUSTEES, THEIR TERM AND POWER TO CO-OPT:

##### Number of Trustees

The Trust will be managed by a **Board of Trustees** consisting of not less than 2 trustees and not more than 9 trustees. The parties of the Second Part will be First Trustees and they shall automatically form the Board of Trustees.

##### Managing Trustee

The first **Managing Trustee** of the trust shall be **SRI ADITYA KUMAR AWASTHI** and he will hold office for his life time. The Managing Trustee, during his life time, can nominate any person to hold office of the Managing Trustee after his demise. In case of demise or relinquishment of office of the Managing Trustee without nominating his/her successor in office, the remaining trustees shall elect any one persons from his/her legal heirs as Managing Trustee. This rule will be followed for all succession of Managing Trustee.

##### Term of Trustees

The term of office of First Trustees shall be for their respective lives. The Board of Trustees shall have the power to increase the total number of Trustees upto the maximum number stated above and fix their term as per provisions contained herein.

The Trustees, who are not First Managing Trustee or First Trustees, shall hold office for a period of one year from their date of appointment by the Trustees. At the end of this one year period, the Board of Trustees may reappoint them for subsequent term or appoint other persons as Trustees in such a manner that the total number of Trustees does not exceed the approved maximum number of Trustees.













##### Retirement of Trustees

Any Trustee, including the Managing Trustee may retire from the Trusteeship hereof by giving two calendar months notice in writing of his or her intention to do so, to the Board of Trustees and after the expiry of the period of notice, the Trustee giving the notice shall ipso facto cease to be a Trustee of these presents.

Any trustee who becomes insolvent, permanent physical disable, unsound mind or he is sentenced to imprisonment by a court for any financial offence will automatically retire from the trusteeship from the date of declaration of insolvent, disable, unsound mind or sentenced to imprisonment.

##### Casual Vacancy

Any vacancy caused by death of any one of the First Trustees, or any vacancy caused by the resignation of any of the Trustees, may be filled up by co-option by the Board of Trustees. The co-opted trustee will hold office till the remaining term of outgoing trustee or till regular trustee is appointed.



## Removal of Trustees







If at any time any trustee is found to be suffering from physical or mental disability or if he is accused of misfeasance of trust funds or property or misconduct with other trustees, employees of the trusts or institutions run by the trust, an enquiry committee will be setup to enquire into the charges/allegations. As per enquiry committee report if the charges/allegations are found correct, the Board of Trustees will be authorized to remove the accused trustee from the Board after providing an opportunity of hearing to trustee to defend him/herself and the decision of the Board will be final and binding on the accused. The accused trustee will not be entitled to participate in any proceedings and working of the trust during the period of investigation.

The proceedings of the Board of Trustees shall not in any way be invalidated due to any post or posts remaining vacant. During the time when a vacancy is yet to be filled up, the remaining Trustees shall act as "**Full Board**", subject to the presence of Quorum in the meetings. Any vacancy in the Board of Trustees or illegality in the appointment of Trustees or their proceedings shall not invalidate any prior act or decision of the Board.

## V. TRUST ADMINISTRATION AND POWER TO THE BOARD:













The **Board of Trustees** shall have power to:

1. To administer the Trust, its properties and affairs and do all the things which will fulfill the performance of the objects for which the Trust is established and for this purpose the Board can apply the whole or any part of the Trust property towards the payment of the expenses of the Trust.
2. The income and the properties of the Trust will be solely utilized towards the objects of the Trust and no portion of it will be utilized for payment to the Settler, or Trustees or their family members/relatives by way of salary, allowances, profit, interest, dividend etc. However this condition will not apply in case of payment of salary to any trustee/family member/relative of the trustees who are technically/professionally qualified and the payment is made against the services provided by such trustee or his family member/relative if the payment is in consonance with his/her qualification/experience and payment to other employees having similar qualification/experience for similar services provided by those employees.
3. To open one or more bank accounts with any scheduled Bank. The bank account will be operated by the **SRI ADITYA KUMAR AWASTHI** individually. The mode of operation of the Bank account may be changed by the Board at any time with mutual consent.
4. To invest the Trust funds in the manner not prohibited by any provisions of the Income Tax Act, 1961.
5. To buy, sell, mortgage, grant, lease, hire or otherwise alienate all or any of the properties of the Trust in its discretion for adequate consideration and for the benefit of the trust and/or to fulfill/achieve the objects of the trust.



6. To execute power of attorney or powers of attorney to any person for the purpose of executing, administering or managing the whole or any part of the Trust for the purpose of all or some among the objects of the Trust.
7. To borrow money from any Bank, Financial Institution, Company, Person, Society, Authority, Entity or Body with or without security and to pledge, mortgage, hypothecate the movable and immovable properties of the trust whether present or which may be acquired in future to secure the money borrowed and to repay the money borrowed.
8. To obtain Bank Guarantee from the Bank which may be required to submit to any authority like Govt., MCI, CCIM and University to get approval/affiliation for running any course and to mortgage, pledge and hypothecate assets of the trust to secure the guarantee issued by the Bank.
9. To receive, collect and enforce recovery of all monies due or payable to the Trust and grant receipts and discharges therefore.
10. To settle, compromise or compound any disputes or refer the same to arbitration or litigation.
11. To receive voluntary contributions from any person or persons from India or outside, after complying with the statutory formalities, by way of donation, gifts or in any other manner and to hold the same on behalf of the Trust for the objects set forth herein.
12. To receive donations, grants, contributions in cash or in kind from any person, institution, department, authority, body, company, govt., MLA/MP Nidhi, agency and to hold the same on behalf of the Trust for the objects set forth herein.
13. To appoint, suspend, dismiss or otherwise deal with the staff required for the administration of the Trust, to frame rules relating to their salaries and other benefits and generally to exercise all powers ancillary and incidental to effectively carry out the objects of the Trust.
14. The Board shall have power to make and rescind rules and regulations for the management and administration of the Trust.
15. No Trustee shall commit any act or breach of Trust of the Trust fund or property or cause any loss to the Trust property or commit fraud in the administration of the Trust fund / property.
16. The Trustees shall hold honorary office and shall not be entitled to any Salary, allowances or perquisites, except for the reimbursement of actual expenses incurred in connection with attending to the Trust matters.
17. The Board of Trustees will follow the instructions given by any donor who makes substantial contribution towards furtherance of the objects of the Trust, so long as such instructions are not detrimental to the attainment of the objects of the Trust and are in conformity with the provisions of the Income-tax Act, 1961 or any other law time being in force in India.



## VI. MEETING OF THE BOARD OF TRUSTEES:

- 1) The Board of Trustees should meet at least once in every calendar quarter and may meet more often when required.
- 2) The meeting of Board of Trustees shall be convened by the Managing Trustee and he shall preside over the meetings. In his absence, the Managing Trustee may nominate any other senior trustee to be the Chairman of such meetings. In the event the Managing Trustee is not able to attend the meeting already convened and has not nominated any trustee to preside over the meeting, the Trustees present in the meeting may elect one amongst themselves to be the Chairman of the meeting.
- 3) One half of the Board of Trustees or a minimum of two trustees, whichever is higher, shall constitute the QUORUM for the Board of Trustee meetings.
- 4) All decisions shall be carried out by the majority decision of the Board but in the event of equality of votes, the Chairman presiding over the meeting shall have a casting vote.
- 5) Any resolution in writing signed by all the Trustees by circulation shall have equal force as though it has been passed at a meeting of the Board of Trustees.
- 6) The meeting of the Board shall be conveyed after giving at least a week's notice unless all the Trustees agree to accept a shorter notice.
- 7) The Board of Trustees may invite other persons interested in the objects and functioning of the Trust to attend the meetings of the Board, but they shall not be entitled vote in the meetings of the Board.

## VII. BANK ACCOUNT:

One or more Bank Account(s) will be opened in any scheduled Bank(s) in the name of the Trust. The Bank account will be operated by **SRI ADITYA KUMAR AWASTHI** individually. However the Board of Trustees may authorize any other trustee/person, by a resolution, to operate the any one or more bank account(s).

## VIII. INVESTMENT OF TRUST FUNDS:

- 1) The Board of Trustees shall have the power to invest the funds, assets and properties of the Trust at their discretion in accordance with the provisions of the Income Tax Act, 1961.
- 2) The Board shall also determine from time to time, the amount it shall spend on the various activities of the Trust.

## IX. ACCOUNTS AND AUDIT:

- 1) The financial year of the Trust shall be from 1<sup>st</sup> April to 31<sup>st</sup> March of the following year, unless otherwise decided by the Board of Trustees.

2) The Board of Trustees shall maintain true and correct accounts of the Trust.

3) The accounts of the Trust shall be annually audited by a Chartered Accountant appointed by the Board of Trustees and the audited statement of account shall be placed before the Board for its approval within six months of the close of the financial year.

#### X. AMENDMENTS:

1) While this Trust shall be irrevocable, the Board of Trustees may amend any of the clauses except those relating to objects of the Trust, the Managing Trustee and Trustees, at a duly convened meeting of the Board with at least 2 weeks' notice, and by a resolution passed by at least three-fourths majority of the Board of Trustees present and voting. The Board of Trustees may add the objects which are in consonance with the existing objects and are necessary to attain the existing objects of the trust or add any other object purely of charitable nature and can be carried on easily with the existing objects. The amendments to the Trust deed can only be passed by a resolution of the Board of Trustees in an actual meeting and not by circulation. The board of trustees will not be entitled to amend/delete any of existing objects mentioned above.

2) If any alteration or amendment is necessary, the same shall be affected through supplementary deed/deeds, duly registered, and these shall be read together with the main Trust deed.

#### XI. INDEMNITY:

The Board of Trustees shall be indemnified, for any loss or damage occurred to them, for any act done by them in good faith and in the ordinary course of the administration of the Trust.

#### XII. SETTLOR AND THEIR RELATIVES:



Notwithstanding the powers vested with the Trustees under the proceeding clause, no part of the income of the Trust shall benefit, directly or indirectly, the trustees and no part of the income of the property of the Trust shall be used or applied directly or indirectly for the benefit (except as mentioned in clause V(2) above) of:

(a) **SETTLOR, Managing Trustee, Trustees** or any person who makes a substantial contribution to the Trust or of any relative of the **SETTLOR, Managing Trustee, Trustees**.

(b) Any "**related concern**" in which any of the above persons has substantial interest.

(c) For the purpose of this clause, the word "**relative**" and the phrases "**related concern**", "**substantial interest**" and "**substantial contribution**" shall have the meanings assigned to them in the Income Tax Act, 1961.




### **XIII. APPLICABILITY OF TRUST ACT:**

The provisions of the Indian Trust Act 1882 shall apply to all matters not specifically mentioned in these presents.

### **XIV. APPLICATION OF INCOME TAX ACT:**

All clauses herein are intended to secure exemption from Income Tax on the income of contributions and donations to the Trust and any clause or portion of this Deed of Trust which is inconsistent with or repugnant to the sections of the Income Tax Act, 1961 as amended, substituted or modified from time to time, shall be deemed to be deleted or modified with effect from the date on which the sections to which the clause or part of a clause is repugnant or inconsistent comes into force.

### **XV. THIS TRUST IS DECLARED IRREVOCABLE.**

### **XVI. DISSOLUTION:**

In the event of dissolution of the Trust, the entire Trust funds shall be realized and first be used for payment of liabilities of the Trust. The assets left, if any, shall be donated to any other Trust(s) or Association(s) having similar objectives and are duly registered with the concerned authorities and in no event it shall be distributed in any manner, **to settler or any of the Board of Trustees or their relatives or related concerns.**

#### **Restrictions:**

1. The registration of the school's trust shall be renewed from time to time.
2. The school managing committee shall consist of one member to be nominated by the director of education.
3. That the school shall ensure that minimum of 10 percent seats shall be reserved for maritonus students of schedule caste/schedule tribe candidate and they will not be charged fee for different classes, more than the fee fixed in the school managed by of U.P. Madhymik shikha/basic shikha parishad.
4. That the trust shall not demand any grant/aid from the state govt.
5. That the school shall not pay less salary and other admissible allowances to the teaching and non teaching staff in comparison to the salary and other admissible allowances, Admissible to the govt. Aided private educational institutions.
6. That the school prepare service regulations for their employees and they will be award retirement benefits as per the norms prescribed for Govt. Aided private Higher Secondary school.
7. That the Trust will, adhere to all the directions issued from time to time by state Govt.
8. That the Trust shall maintain all records in prescribed register.
9. That no amendment/change/modification shall be made in the conditions mentioned above without prior approval of the state govt.

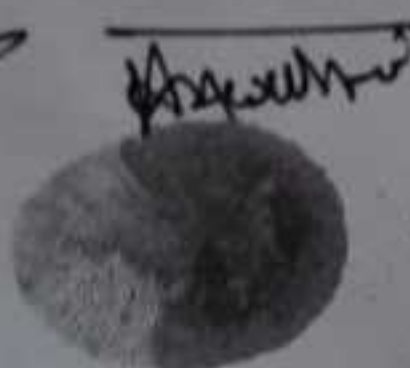
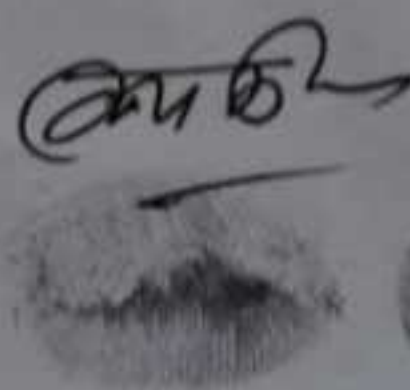

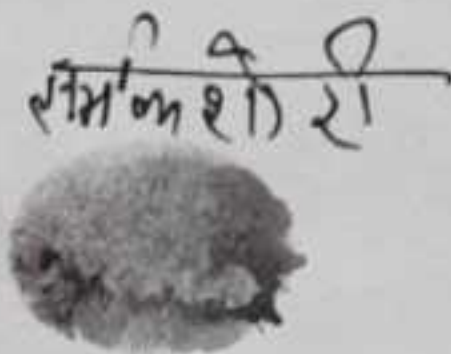
